

Personal Data Processing Consent for the MAVIBOT Service

By providing my data on the website [MaviBot.ai](https://mavibot.ai) (hereinafter - the Website), including during registration and while performing any other actions, **I confirm that all the provided personal data belongs to me personally. I also hereby give my consent voluntarily and in my own interest, free from coercion by any third parties or by the Administration of [MaviBot.ai](https://mavibot.ai).**

I, as the subject of personal data, hereby voluntarily and of my own free will provide my consent to the processing of my personal data. This consent applies to operations performed both with and without the use of automation tools, including: collection, recording, systematization, accumulation, storage, clarification (including updating and modification), retrieval, use, blocking, deletion, and destruction of my personal data by **LIMITED LIABILITY COMPANY-FZ 'MAVIBOT'** (also known as MaviBot L.L.C-FZ) (hereinafter referred to as the Company).

Purpose of personal data processing:

- Customer acquisition and sales execution via the [MaviBot.ai](https://mavibot.ai) Service;
- Connecting integrations to the [MaviBot.ai](https://mavibot.ai) Service (including messengers, social networks, and payment processing services);
- Payment for the [MaviBot.ai](https://mavibot.ai) Service;
- Exchanging important information (including legal information) with the [MaviBot.ai](https://mavibot.ai) Service.

List of personal data for the processing of which I provide my consent:

- Last name, first name;
- Email address – in case of registration via email, as well as for the exchange of documents and other important information (including legal information) with the MaviBot.ai service;
- Apple ID – only in case of registration via Apple ID;
- Mobile phone number or email address – only in case of registration via Facebook;
- My personal photographs – only if I registered via Facebook, uploaded my personal photo in my account settings, or uploaded my personal photos in another section of the [MaviBot.ai](https://mavibot.ai) service;
- Video – only if I upload video files to MaviBot.ai where my face or part of it is visible;
- Bank account details: Bank account number, bank name, bank's correspondent account, bank's Tax Identification Number, bank's Registration Reason Code, bank's Identification Code – only for making payments to the Company and for refunding my balance of unused funds according to *the Terms of Service*;
- Legal entity details for representatives of legal entities: Representative's position, legal entity name, legal entity details – in case I am a representative of a legal entity and pay for the Service's services via issued invoices;
- Data from messenger/social media accounts: This includes, but is not limited to, photos, videos, unique username, profile description, access tokens and keys (for integrations), etc. – in other words, data from messenger or social media accounts that I use to:
 - either register on the [Mavibot.ai](https://mavibot.ai) website;
 - or connect a messenger, social network, or payment service to Mavibot.ai for using the Service.

I agree that by uploading any other personal data of any type and kind to the [MaviBot.ai](https://mavibot.ai) Service that can be used to identify me on the Internet, I am solely responsible for the security of such personal data.

I agree that I am responsible for the security of my personal account and the data stored within it if I grant access to my account to third parties. This specifically applies if I disclose my login, password, and two-factor authentication code (if two-factor authentication is enabled on my personal account) to third parties.

I have the right to withdraw my consent to the processing of my personal data at any time, unilaterally. The withdrawal is to be executed by preparing a written document, which may be:

- Sent by any other permissible method.

I have been informed that if I withdraw my consent to the processing of personal data, or withdraw my consent to the processing of any specific personal data listed in this Consent, **I WILL NO LONGER BE ENTITLED TO USE THE [MAVIBOT.AI](#) SERVICE. THIS IS BECAUSE, IN SUCH A CASE, THE COMPANY WILL BE OBLIGATED TO DELETE MY PERSONAL DATA, INCLUDING THE EMAIL (OR PHONE NUMBER, OR APPLE ID) THAT WAS USED DURING REGISTRATION ON THE WEBSITE. THIS WILL RESULT IN THE COMPLETE DELETION OF MY PERSONAL ACCOUNT ON THE [MAVIBOT.AI](#) SERVICE.**
